President's Message

Paul DePasquale, MPA, R.S.

I recently attended the National Environmental Health Association (NEHA) Conference in Grand Rapids, Michigan in early July and came away from it with many positives for environmental health and our association. I had the opportunity to hear



Representative Brenda Lawrence (D-Michigan) deliver the conference keynote address that had some very interesting and encouraging news. She introduced new federal legislation a few months ago called the Environmental Health Workforce Act of 2017. She stated that this legislation is an important step on the journey to ensuring that every American family is protected through capable public servants who are experts at preventing and responding to outbreaks such as a global pandemic. Rep. Lawrence believes that to have a strong public health system we need a strong environmental health workforce.

The Environmental Health Workforce Act of 2017 will:

1. Direct the US Secretary of Health and Human Services (HHS), in conjunction with relevant stakeholders, to develop model standards, guidelines, and technical assistance for credentialing environmental health workers.
2. Direct HHS to develop a comprehensive environmental health workforce plan that identifies and addresses ways to strengthen the environmental health workforce.
3. Direct the Comptroller General of the United States to examine and identify best practices in 6 states related to training and credentialing requirements for environmental health workers. This report

will compare the best practices of 3 states that currently have credentialing requirements (Maryland, Ohio, and Washington) and 3 states that do not have such requirements (Michigan, Indiana, and Pennsylvania).

We all should support this legislation and applaud Representative Lawrence for her leadership and support of environmental health. In Ohio, the abolishment of the RS Board and the future of the Registered Sanitarian and Sanitarian-In-Training credentials are issues that many OEHA members feel very deeply about. This federal legislation could have an impact on the future of our credentials.

One of my responsibilities at the conference was to attend affiliate meetings with other state association presidents and share thoughts, ideas, and experiences. I was very encouraged to find that OEHA's structure, policies, and member commitment to the organization is second to none and we are in very good shape fellow members. However, we can always find areas to improve and one of them is membership.

We can and should try to increase OEHA membership. Membership currently stands at 545 members. This number typically increases as people sign up for Fall Conferences. Usually we see an increase of around 30 or more members during the conference registration period. Currently, there are around 1400 Registered Sanitarians and Sanitarians-In-Training in Ohio. I think we can increase our membership to 900, but it's up to each and every one of us to do it. I challenge each member, all 545 of us, to recruit one person this year from your office that isn't a member and encourage them to join. If each one of us recruits one, we will exceed our goal and beyond. To help in your recruiting efforts, here are some benefits to being a member:

- Continuing Education – advance your career by attending educational conferences. OEHA puts on five (5) quality conferences a year at a

discounted member rate.

- Ohio Journal of Environmental Health – is an excellent source for timely Ohio EH information. Members receive this journal 4 times per year.
- Legislative Updates – OEHA members receive e-bulletins with the latest news and action items on issues that are critical to environmental health.
- President Updates – members receive e-bulletins monthly highlighting the most recent and relevant EH and OEHA news delivered to your email.
- Leadership Development – OEHA started an EH Leadership class last year.
- Be an EH Advocate – Contribute to OEHA’s increasing efforts to be a champion for environmental health professionals on vital policy and legislative issues by joining an OEHA committee or becoming a committee chair.
- Connect with other EH professionals – When you become a member of OEHA, you join a network of professionals who are committed to advancing and protecting the field of environmental health.

Finally, I would like to leave you with a reminder to take advantage of all that OEHA has to offer including scholarships, education, professional development, and networking. This is your association and it is only as good as you make it.

Board of Sanitarian Registration Moving to Ohio Department of Health

As you may now know, the Governor's Budget Bill (HB 49) was signed into law on June 29, 2017. As part of that legislation, the Board of Sanitarian Registration was abolished and the administrative functions related to the registration of sanitarians in Ohio will be moved to the Ohio Department of Health (ODH). This change becomes effective on September 29, 2017. The entity formerly known as the RS Board will now be known as the Sanitarian Advisory Board. As part of this consolidation, the physical location of the office will be moving to 246 North High Street, Columbus, Ohio, within the ODH Bureau of Environmental Health and Radiation Protection (BEHRP).

While our name and office location will change, many things will remain the same, including Stephanie Youst continuing to serve as the Program Administrator for the Sanitarian Advisory Board. The law has not changed with respect to the requirements to be a Registered Sanitarian or Sanitarian in Training meaning that:

- Individuals are still required to renew their registration on an annual basis;
- The definition of the practice of environmental health has not changed;
- There is no change in the educational requirements to become registered;
- There is no change in the testing requirement;
- There is no change in the continuing education requirement; and
- The licensure portal (eLicense) will continue to be used for all application and renewal processes.

To facilitate a smooth consolidation, a Transition Team has been formed that consists of several current Board members, staff members at ODH, Stephanie Youst and Chad Brown representing OEHA. The Transition Team is working very hard to ensure a smooth transition and will keep you informed of the progress along the way through notifications in *OJEH* and postings on the OEHA and Boards websites (www.sanitarian.ohio.gov).

Obviously there is much work to be done in a very short period of time. Our goal is to provide you with uninterrupted service during the transition and to maintain the high levels of customer service you have become accustomed to when dealing with the Board. We look forward to your continued support during this transition. If you have any questions regarding the upcoming changes, please do not hesitate to contact the Board office.

Vice President's Message

I am honored and privileged to serve as OEHA's vice president this year. In addition to having a full-time job as a sanitarian, I am also married with three wonderful children; Jacob, Gavin, and Cecelia at 9yrs, 13yrs, and 19yrs old respectively. I am a native resident of Northeast Ohio. With the exception of a few years in Florida, I have lived in Ohio all of my life.



I received my Bachelors of Science degree from Kent State University in 1997. Over the past sixteen years I have been working as a public health professional gaining invaluable experience in a wide range of environmental health programs.

My public health career started at the Akron Health Department's Housing Division in 2001. I performed residential housing inspections, investigations, education and enforcement activity under the City of Akron's Environmental Health Housing Code. My housing experience at Akron really exposed me to the legal process and the importance of enforcement. I prepared and filed more than three dozen search warrant and/or complaint affidavits as well as provided expert testimony in dozens of court appearances. I began working in the Food Safety and Recreational Water programs in Akron in 2009.

In January 2011, I began my career at Summit County Public Health (SCPH) as a result of the merger of three health departments in Summit County. Currently I am a program coordinator for the Food Safety and Recreational Water programs at SCPH. I am charged with coordinating educational opportunities for our staff and the public, program expansion and development, as well as special projects in the recreation water and food programs.

I have also worked in the Water Quality programs at SCPH conducting inspections on household sewage treatment systems (HSTS) and private water systems (PWS).

I participated in writing and executing the 2015 SCPH grant proposal to the National Association of County & City Health Officials (NACCHO) for the Retail Food Regulatory Program Standards, Mentorship Program (Cohort 5). This application secured grant funding to further our agency's progress toward conformance with the FDA Retail Food Standards Program.

In 2015, I participated in the Ohio Environmental Protection Agency (OEPA) accreditation process to certify the SCPH laboratory for microbiological analysis of drinking water. I am also an OEPA accredited water quality analyst responsible for performing analysis of potable water by MMO-MUG for total Coliform and E.coli using Colisure (SM9223-B). This year, in addition to potable water, our lab is testing all of our storm water and beach water samples as well. Our lab is beginning an expansion effort to test for Nitrates/ Nitrites and heavy metals in drinking water and I am the collaborator in this project.

I believe in the value of having diversified work experience as I have worked in many EH programs. This varied experience gives me a better professional perspective and helps me see the forest through the trees. During my career I have been fortunate to work with and be mentored by some of the most talented professionals in public health.

I am continually impressed with the dedicated professionals I have met through this organization. The planning committee and I are working hard to prepare for our 2018 AEC on April 17th & 18th at the Doubletree in Worthington, Ohio. I look forward to seeing you all there!

A Message from the State Board of Sanitarian Registration

Thank You from the State Board of Sanitarian Registration

With the adoption of House Bill 49 (the budget bill), the administrative functions related to the registration of sanitarians in Ohio passes from the State Board of Sanitarian Registration (RS Board) to the Ohio Department of Health (ODH). This change becomes effective on September 29, 2017. Note that the law has not changed with respect to the requirements to be a Registered Sanitarian to practice environmental health in Ohio. Individuals are still required to maintain their registration on an annual basis; the definition of the practice of environmental health has not changed; there is no change in the educational qualifications; no change in the testing requirements; no change in the continuing education requirements. The Board will remain active until its functions are transferred to ODH on September 29, 2017.

The Board is working closely with ODH to assure a smooth transition. The Board will keep you informed through notifications in *OJEH*, postings on the OEHA website as well as the RS Board website (www.sanitarian.ohio.gov). Check there if you have any questions and for the latest information. Of course, you may always call the RS Board Office with questions.

The members of the Board would like to personally thank all Registered Sanitarians and Sanitarians in Training, the members of OEHA and particularly Paul DePasquale, Chad Brown and Garrett Guillozet for their efforts. This is an issue that we all feel very deeply about and their support and hard work behind the scenes to keep the Board intact as an independent organization is a testament to their support of the profession of environmental health. We look forward to your continued support during this transition so that we do not lose any of the integrity of the Board and its mission.

Northeast District Conference



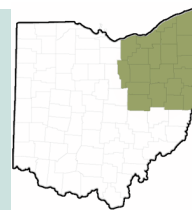

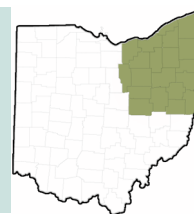

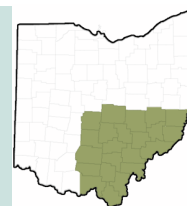

Mr. George Eagle, Ohio Department of Health, Engineering Division, was appointed chairman of a committee to develop a clinic on Refuse Disposal.

A very informative panel discussion on sewage disposal was given. Aspects of rural, subdivision, milk plant, and slaughter-house sewage disposal were presented. George Eagle, C.D.H.; G. E. Flower, Commissioner of Sewage Disposal at Cleveland; G. A. Hall, Ohio Water Pollution Control Board; A. H. Ritter, Assistant Engineer, Ohio Department of Highways; Stanley Strine, Deputy Health Commissioner, Stark County Health Department, ably covered the subject.

Mr. Robert McKean, member of the Public Employee Retirement Board, gave some very thought-provoking remarks about our pension plan. Above all, he emphasized that it is high time we took a little more interest in the plan's provisions. Perhaps we should discuss the problems involved at our next annual meeting?

Mr. Norman Clark was introduced as new Secretary-Treasurer of the Association. He is filling a vacancy created when Steadman Overman left for Chapel Hill to complete work on his M.P.H. at the University of North Carolina.

Walter D. Tiedeman, Director, National Sanitation Foundation, discussed some of the foundation's accomplishments and plans for the near future.

Among these are: the removal of numbers 1, 2, and 3 from the standards and seals of approval. Seems that some companies have been using the numbers as "sales talk", e.e.
